## Terms and Conditions:


### 1. Nature of Relationship:

- 1.3 Both the parties shall take all reasonable steps to ensure the successful completion of the collaboration and co-operation with each other duly carrying out the obligation agreed upon
- 1.4 Sri G.V.G Visalakshi College for Women, Udumalpet shall bear all expenses required for training.

### 2. Mutual obligation:

- 2.1 This collaboration shall not be exclusive to both parties and shall not disallow each party from having similar collaborations with others except as explicitly stated in this MoU. There shall be no obligation on any party to compensate the other in any manner or to take any claim.
