Friendliness Resources provided in the Institution:

To help students with special needs campus has made tremendous strides, that buildings be accessible to those with physically impaired and visually challengeable.



Provision for lift: Yes. The elevator facilitates for easy and quick movement through the different floors of the college is provided to physically impaired students in the new two - storied building. The facility may be availed by both staff members as well as differently-abled students. The lift facility is operated at all times to enable safe movement of people those who are in need.

Ramp: YES. In the Institution Ramps are used instead of staircases. Five blocks provide these facilities for the use of people who move about in wheelchairs.





White cane with Handle: This tool is provided for hindrance free mobility as well as to detect objects in the path of a user. A white cane is provided to visually impaired student to make her movement comfortable and safe in the premises by the institution.



Rest rooms: Yes. It is provided. Accessible toilets are designed with large floor space to make easy in and out movement of wheelchairs and unisex compartments accessible for the wheel chair user.



Voice recorder is provided to listen or record the lectures. It is one such friendly resources provided by the Institution to the visually challengeable student to make learning a burden less process.





Scribes for Examination: Yes provided. To transcribe the answers by the student in University examinations and in CIA tests. The scribe facility is also provided for the students those who have difficulty in producing clear text or diagrams for many different reasons.

Besides these provisions the students have a friendly ambience to make them feel ease by sharing the common interest and considering their social responsibilities in making them one among. Thus the college provides a friendly aura to the physically impaired and visually challengeable students.

Also, the same scribe cannot be used by more than one candidate. If violation of the above is detected at any stage of the process, candidature of both the candidate and the scribe will be cancelled.
