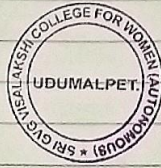
✓ Principal finalized the list of members to be registered in the UGC website.

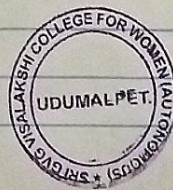
