Progress Report of the Paramarsh Activities

The UGC Paramarsh team of Sri GVG Visalakshi College for Women, Udumalpet, conducted a Pilot study, identified the potential and challenges of the six Mentee institutions. A formal MoU was signed to guide and enhance the overall quality of the institutions, thereby going for NAAC Accreditation. The team along with experts organised Orientation Programmes, Training sessions, Workshops, Guest Lectures, Webinars catering to the needs of the institutions for self-improvement. Preliminary and intermediate audits, document verification (both onsite and online), Counseling on individual basis for day to day clarifications and regular consultation meetings were conducted to equip the institution to apply for NAAC Assessment. The Mentor institution is still rendering (inspite of lapse of MoU term) and will continue to offer additional services to enable the mentee institutions to get accredited.

Reasons for Delay in submitting SSR:

i) Specified by the Mentee Institutions

- COVID-19 Pandemic: Many families were affected by COVID-19, Dropouts, Admission in downtrend
- Comprehending the RAF of NAAC Assessment
- Floating faculty
- Data compilation slower than expected
- Identification and collection of evidences time consuming
- Lack of awareness on quality among faculty

ii) Other Observations by the Mentor Institution:

- 4 COVID-19 Pandemic: Cut-in-salary for the faculty
- ✤ Lack of coordination among faculty
- Insufficient data and inappropriate documentation Data compilation time consuming
- Fear of low Grade as they may not meet all parameters.
- Short period of direct contact with faculty of Mentee Institutions due to Covid -19 pandemic
- Online meetings are not impactful as offline meeting
- Not able to pay Assessment fee due to less student intake (Cheran College for Women, Tiruppur)
- Lack of stable leadership Frequent change (Cheran College for Women, Tiruppur)
