The following were the resolutions made by the Board and approved.

#### Resolution No. 1:

Resolved that the curriculum framework and design of course content be approved for Part III Core for UG History Programme under Outcome Based Education for the semesters I -VI along with the course contents for the courses offered for the students admitted from the academic year 2021-2022 onwards.

#### The following are the revamped and newly introduced core courses:

- 1. Core I Main Currents in Indian History upto AD 647 offered in semester I, revamped and to be offered as Core I Main Currents in Indian History upto AD 1206 (121H01).
- 2. Core II Main Currents in Indian History AD 647- AD1526 revamped and to be offered as Core II - Main Currents in Indian History AD 1206 - AD 1707 (121H02).
- 3. New Core III History of the Marathas (221H03) to be offered in Semester II replacing Main Currents in Indian History AD 1526 to AD 1707.
- 4. Core IV Main Currents in Indian History AD 1707 AD 1857 revamped and to be offered as Core IV Modern Indian History upto AD 1905 (221H04).
- 5. Core V Main Currents in Indian History from AD 1858 AD 1919 revamped and to be offered as Core V - Main Currents in Indian History AD 1906 - AD 1966 (321H05).
- 6. New Core V I Sangam Age in Tamil Country (321H06) to be offered in Semester III
- 7. Core VIII History of Tamilnadu upto 1336 to be offered as Core VII History of the Tamil Country from Kalabhras to Imperial Cholas (421H07) in Semester IV with modification in the course content.
- 8. New Core VIII History of Udumalpet (421H08) to be offered in Semester IV.

- 9. Core VII Main Currents in Indian History AD 1965 AD 2014 offered in Semester IV revamped and to be offered as Core IX Main Currents in Indian History AD 1966 AD 2014 in Semester V (521H09).
- 10. Core IX History of Tamilnadu AD 1336 AD 1806 offered in Semester V to be offered as, Core X History of Tamilaham from Second Pandyan Empire to Nayaks of Madurai (521H10) in Semester V with modification in the course content.
  - 11. Core XV India and her Neighbours offered in Semester VI to be offered as Core XI in Semester V with modifications (521H11).
  - 12. Core X World History AD 1453 AD 1789 offered in Semester V to be offered as Core XII World History AD 1453 AD 1788 (521H12) in Semester V with modification in the course content.
- 13. Core XIII Tamil Country in the 17<sup>th</sup> and 18<sup>th</sup> Century (621H13) to be offered in Semester VI instead of Core XI History of China and Japan AD 1800 AD 1970.
- 14. Core XIV History of Tamilnadu from AD 1806 AD 2016 (621H14) to be offered in Semester VI revamping Core XIII History of Tamilnadu AD 1807 AD 2016 offered in Semester VI.
- 15. Core XV World History since AD 1789 (621H15) to be offered in Semester VI revamping Core XIV World History AD 1789 AD 2000.
