- 4. Course outcomes to give weightage for Higher Order Thinking Skills (HOTs) as an exhancement to Lower Order Thinking Skills (LOTs)
- 5. Introducing core course options for each programme under CBCS.
- Incorporating the entrepreneurial domain atleast for one core course that would develop skills under CBCS.

- Total number of credits can be increased from 140 to 150 by increasing core courses (or) electives credits with 10-20% online components.
- 2. Credit transfer for regular courses can be attempted.
