

This Memorandum of Understanding (MOU) entered and executed at Udumalpet on **28.12.2022**

Between

PACE ACADEMY, Coimbatore, the first Party, and represented herein by its **Founder & CEO, Er.P.KARTHIKEYAN** (hereinafter referred as 'First Party', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

And

SRI GVG VISALAKSHI COLLEGE FOR WOMEN, Coimbatore, second party and represented herein by its **PRINCIPAL, Dr.N.RAJESWARI** (which expression shall mean and include its successors in office and assigns)

RECOGNISING the significance of their partnership for developing a student training & development program to meet the growing talent gap in the competitive exams hereby agree to execute this memorandum of understanding for the mutual benefit of Training Centre and institution free from any financial commitments by either party.

AIMS AND OBJECTIVES:

1. **Purpose:** The purpose of this MoU is to deliver Competitive Exams Skill programs.
2. **Guest Lectures:** First Party to extend the necessary support to deliver guest lecturers to the students of the Second Party on the technology trends and in house requirements.

FIRST PARTY:

- A1. First party will organise training for the students of second party.
- A2. Minimum 50 number of students should participate in the training programs. The fee for the training program is fixed mutually by both the parties.
- A3. The training program will be conducted on scheduled days as per mutual convenience. The students should attend all the programs conducted by First party during the training period.
- A4. First party will train the student technically and practically in the classroom and will not provide any printed material to anyone.

B. SECOND PARTY:

B.1. Classroom, electricity, Furniture, and lab facilities has to be provided for training Programme by the second party.

B.2. The fee for the training program is fixed mutually by both parties. The training Programme fee has to be collected from the enrolled students by the Second party.

B.3. Payment for the training program should be 50% advance against the confirmation / before commencement of the classes.

B.4. The student data for program are to be submitted to First party before the commencement of Training by Second party.

B.5. Balance 50% of amount has to be paid after completion of training program, and then the invoice can be raised within 7 days.

I ANNEXURES, AMENDMENTS & REVIEWS

1. Annually, the authorized person or the joint working group as formed under this MoU shall review this agreement for purposes of determining if amendments are needed as may be decided mutually between the parties.

2. This MoU can also be amended by mutual consent through an exchange of correspondence between the two parties.


II. DURATION OF THIS MOU


