3. Offer Internship and part time employment for students (earn while you learn).


This MoU provides provision for students of GVG to interact with VSLMS whenever required to complete the above said tasks successfully.

Both Parties, being legal entities in themselves desire to sign this MoU for advancing their mutual interests.


This MoU is valid for three years from this 15th day of October, 2022 until 10th day of October, 2025.
