AND WHEREAS the scheme under the said MoU is valid for a period of three years w.e.f., 20.08.2021 which was extended and is set to expire on 19.08.2024


AND WHEREAS the parties have decided to continue the said MoU and the Scheme beyond the expiry date for a period of three years.
