

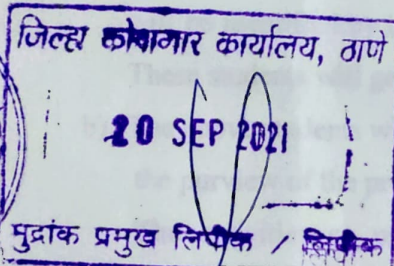

1. Objective of MOU:

The objectives of the MOU are:

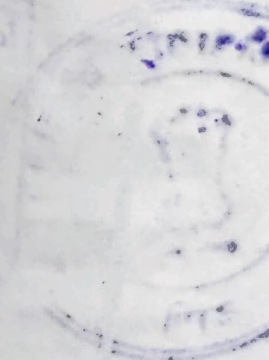

- b) To provide exposure to the students about learning aid & infrastructure of the Institutions offering same Specialization affiliated with the University within the State of Maharashtra.
- c) To inculcate in students competitive skills for enhancing their academic interest.
- d) To promote research/continuing education activities between both the institutions.

2. About the Faculty and Students Exchange Program:

The MOU is between the faculties of Commerce – (Economics, Commerce) & (Accounting and Finance), Arts - Economics of Smt. P. N. Doshi Women's College, Ghatkopar and Sri G.V.G Visalakshi College for Women, Udumalpet.

- a) **Twenty students 4 teachers from the mentioned faculties/departments** will be identified by both the respective Institutions for purpose of exchange. These students will get exposure of Activities conducted in the other Institute.
- b) The above students will be participating in all the activities undertaken within the purview of the program and will be entitled for participating certificates. The activities so undertaken will help the students in developing their competency and personality.
- c) The activities to be conducted during the program shall be decided by mutual consent of Head of Departments of both the Institutions.
- d) The Head of Departments reserve right for any change of activity by their mutual consent with each other before the conduction of program.
- e) **For the time being because of the COVID 19 restrictions the exchange program will be conducted online till the restrictions are waved off.**

3. Proposed Modes of Collaboration:

The faculties of BCOM: Commerce – (Economics, Commerce) & (Accounting and Finance), Arts – Economics, BCA (Bachelor of Computer Application) of Smt. P. N. Doshi Women's College, Ghatkopar and Sri G.V.G Visalakshi College for Women, Udumalpet. proposes to collaborate through the following:

- a) Propagation of education and training in the areas of mutual interest.
- b) Co-operation and conduction of various activities with consent of faculty members.
- c) A schedule of activities and conduction will be drafted with the agreement and consent of Head of Departments of both the Institutions along with this MOU.

4. Duration of the Program & MOU:

The Students. & teachers Exchange Program shall be conducted between the two Institutions involving exchange of students for six working Days. **The undersigned MOU will be valid for three academic years 2021-2022 to 2023-2024.**

5. Terms & Conditions :

- a) The cost of infrastructural utility including use of classrooms, teaching aids, books, resources, internet, laptops, OHP'S, Projectors, etc. shall be borne by both the institutions individually.
- b) The expenses relating to the Visits, Certificates, Prize, Trophy's, Refreshments, Honorarium expenses for inviting Experts, Judges during the program shall be borne by both the Institutions individually.
- c) The Institutions are free to arrange sponsors for part or whole of the program.
- d) Both the Institutions agree to co-ordinate, co-operate in organizing activities, identifying and inviting the faculty members/ Experts/Judges and arranging for the visits.
- e) The MOU may be amended, renewed and terminated by mutual written agreement of the institutes at any time.
- f) Either institute shall reserve right to terminate this MOU, by giving a written notice of not less than 30 days to the other institute.
- g) Both the Institutions will bear the responsibility of the participating students for the program conducted only.


6. Confidentiality:




7. Co-ordinators:


The responsibility for conduction of this program shall be of the Head of Departments of each of the Institutions. They can depute their faculty members for the exchange program.
