- 1.4 Sri G.V.G Visalakshi College for Women, Udumalpet shall bear all expenses required for training.

## 2. Mutual obligation

- 2.1 This collaboration shall not be exclusive to both parties and shall not disallow each part from having similar collaborations with others except as explicitly stated in this MoU. There shall be no obligation on any party to compensate the other in any manner or to take any claim.
- 2.2 Sri G.V.G Visalakshi College for Women, Udumalpet shall meet the training expenses. Each party shall respect the other's intellectual property and shall not use any trade name, symbol or designation belonging to other, without prior written approval. No party shall hold out as an agent or representative of the other or create any liability for the other.
- 2.3 Both parties shall maintain confidentiality about any information, plans, discussions, strategies or any material which shall be deemed to be confidential.

# 3. Limitation and Warranties

3.1 Each party shall ensure that the other is not put to any liability for any act of the respective party.

- 3.2 Each party represents that they entrust the full power and authority to enter into this MoU in general.
- 3.3 Each party shall ensure that the other does actively solicit the faculty of the respective parties during the period of the MoU

#### 4. General

- 4.1 Both parties shall designate a representative from its side who will be the primary (single) point of contact on behalf of the party.
- 4.2 Both parties shall not use name of the other in any advertisement or make any public announcement without the prior written approval of the order.
- 4.3 Any dispute under this MoU will be settled mutually.
